- Lay approx. 2600m<sup>2</sup> @ 25 to 30mm thick to High St within the Kulin townsite.
- Lay approx., 2000m<sup>2</sup> of Intersection Mix @40mm Cnr Allen Rock Rd & Kulin Holt Rock Rd approx. 85kms East of the Kulin Townsite.
- Lay approx. 2500m<sup>2</sup> of Intersection Mix @40mm to Fence Rd South at the intersections of 101 Gate Rd & Stock Route Rd approx. 46kms Southwest of the Kulin townsite.
- Lay approx. 2000m<sup>2</sup> of intersection mix @40mm to Yealering Rd and Clapton Rd approx. 20kms West of Kulin townsite.

Prices should also include,

- Profiler for ALL tie ins to existing seal works.
- Accommodation
- Mobilisation to and from site
- Traffic Management.

It is anticipated that the works will need to be completed in two mobilisations. November December 2021 and March April 2022.

Other jobs may also be awarded to the winning tender throughout the financial year depending on council's workload.

## **1. Lodgement of Tender**

Late tenders will not be accepted.

## **2. Opening and Registration of Tenders**

All tenders lodged before closing time will be opened and registered at the closing date and time as listed. Any tenderer may be present at the opening and record the prices submitted only.

## **3. Acceptance of Tenders**

The lowest or any tender is not necessarily accepted and canvassing of Councillors or staff will disqualify.

Council will award tenders at their Council meeting of Wednesday 19 August 2020 and notice will be given by 4:00pm Thursday 28<sup>th</sup> July. Acceptance of tender will be effected only by written acceptance after the closing date. This tender and written acceptance thereof shall form the binding contract. A Council Work Order Form will be issued for this purpose.

## **4. Payment**

Payment shall be made within 30 days from the end of the month of delivery of the purchased item. Cash payments will not be made. Goods and Services Tax is applicable to this tender. The tenderer must specify whether the cost per item is inclusive or exclusive of GST.

## **5. Annulment of Contract**

Failure by the contractor to meet the agreed delivery time or any of the technical specifications will constitute grounds for the cancellation of the contract at the discretion of the Shire of Kulin.
