2. SWEARING IN CEREMONY AND ELECTIONS

Declaration of Recently Elected Councillors

The *Local Government Act 1995* Section 2.29(1) indicates that a person elected as President or as a Councillor has to make a declaration in the prescribed form before acting in the office.

The following Councillors read aloud and signed the Declaration by Elected Member of Council, Form 7 (Local Government (Constitution) Regulations 1998, section 13(1)(c); and were formally sworn in, as witnessed by Mary Lucchesi JP:-

Election of President - ensuing two year term

Council is required to elect the President from among the Councillors, as required in Section 2.15 of the *Local Government Act 1995*.

The CEO declared the position of President vacant and called for nominations. A written nomination had been received from Cr Robins. The CEO called for other nominations.

As no further nominations were received, Cr Robins was declared elected unopposed to the position of President for the ensuing two year term expiring in October 2027.

Cr Robins made and signed the Elected Members Declaration, Form 7, witnessed by Mary Lucchesi JP.

Election of Deputy President

The President, Cr Robins took the chair and called for nominations for the position of Deputy President. A written nomination had been received from Cr Smoker. The President called for other nominations.

As no further nominations were received, Cr Smoker was declared elected unopposed to the position of Deputy President for the ensuing two year term expiring in October 2027.

Cr Smoker made and signed the Elected Members Declaration, Form 7, witnessed by Mary Lucchesi JP.

President Robins thanked Mary Lucchesi JP for her time and attendance in witnessing the Councillor Declarations.

3. SEATING ARRANGEMENTS

Allocation of Councillor Seating within the Council Chamber

In accordance with Standing Orders Local Law Part 8.1 *Members to be in their proper places* (1) at the first meeting held after each election day, or at any other time considered necessary, each member is to be allocated a seat at the Council table be the Council.

CEO Alan Leeson conducted a ballot for the seating of elected members, noting that the Shire President and Deputy Shire President positions at the table were already declared.

Elected members vacated their seats and following the ballot for the remaining five seats, councillors assumed their seats accordingly.
