The community of Kulin has certainly been up and about the past few weeks with a few well anticipated rain events. Whilst not overly significant in terms of value, the few 10-15mm events have certainly been welcomed by local farmers and allowed them to finalise their seeding programs. Let's hope these events consistently come over the remaining winter months with a couple of big deluges.

Last week we held our monthly Council Meeting. A large part of this was meeting Council's compliance obligations set by the Department. A big thank you to all staff who worked tirelessly to complete the tasks associated with meeting these obligations, which may seem mundane, but they are requirements for both the administration and Council to meet.

At Council Forum we had initial discussions regarding the proposed budget for 2019/20. A power of work has been put in by all staff to develop the budget, particularly within specific departments. It was a great opportunity for me to witness how staff were able to work collaboratively and have frank and rational discussions about the key financial drivers across the Shire. A big thanks to Cassi who put in long hours to bring the draft budget to Council for discussion. Well done to Judd who put all his IT and spreadsheet skills to the test in developing a comprehensive roads budget, which is a significant portion of the overall budget.

During the budget process we received a few, but limited expressions from the community. Of note was an extensive series of letters from students from the KDHS. These letters clearly articulated what the youth of the community see as key priorities with regard to public infrastructure around town. It was great to hear their passion and witness their well-articulated communication skills. Whilst I cannot pre-empt or make any promises with regard to their budget requests, Council look forward to working closely with these students to workshop their ideas going forward.

I've been also working closely with a couple of students from the KDHS who will be "volunteering" their time to assist Bill Colbourne and Kaye Edwards revitalise and restore the old Kulin Gaol. This is an historic building for the townsite and I look forward to seeing this multi-generational working group produce another community masterpiece that will be a valuable tourist asset.

Friday 14 June saw the CRC host the Family Burger Night at the FRC. What a great event it was with over 80 community members enjoying the comradery and entertainment. A big thank you to the staff and community members who assisted in the preparation of the food. Whilst the original intention was to have "Pitmaster" classes and demonstrations, unfortunately this didn't happen, but it was to see a couple of staff members take the initiative and show case their own culinary skills, congratulations to Alana, Ambrose and Cassi.

This week was the AGM for revitalised Cultivating Kulin Committee. This is another volunteer organisation within the community that is looking innovative funding and delivery initiatives to make the Kulin community a progressive, welcoming and hospital place to live, visit and undertake business. Details regarding this working group can be obtained by talking to Taryn Scadding or Brad Smoker who is the newly appointed Chairperson. Thanks and congratulations to all those community members who put their hand up to be on the community.

On a final note thanks to the dad's of the community who have assisted in installing the cubby house and associated soft fall and retaining wall at the Day Care Centre. Yes it has taken its time, but I'm sure all the kids will love their new and exciting structure.

Water Corporation will be introducing new fees for local government standpipes as of the 1st July 2019. It is based on an incremental scaled system based upon meter outlet size and targeting high volume consumers and commercial contractors. This is known as Water Corporation's "Class Step" classification system. Whereby all meter outlets of 25mm or less will be either Local Authority or Community Use standpipes with Farmlands Tariff. Meter outlets greater than 25mm will be classified as Commercial with differing Class Step classifications depending upon their location relative to the main distribution line and other infrastructure.

In all cases the Shire will be billed for all water usage from each standpipe during Water Corporation's two monthly billing cycle. To recover the costs, users will be invoiced based on the standpipe reports for each location. The Shire is geared to do this with the card reader system producing reports on usage.

At the Ordinary Council Meeting held on 17 April 2019, Council moved to introduce a new fee and charge for Standpipe Water Consumption. These have been advertised via the normal fee and charge advertising process.

This memo provides specific details with regard to the fees and charges for Standpipe Water Consumption set by the Shire of Kulin in the 2019/20 Annual Budget. These charges will be in place from 1 July 2019 and are proposed to be billed quarterly with the first bill being issued 30 September 2019.





Beware tax time scams

The end of the financial year is fast approaching which means it's time to remind taxpayers to be aware of scam attempts that usually spike over the next six months.

Tax scams continue to take a large financial toll on people who are usually cold-called by criminals pretending to be from the Australian Taxation Office (ATO) and demanding a fictitious tax debt be paid immediately. In most cases, the caller threatens their victim with arrest if the payment is not made.

In the 12 months to the end of May 2019, 43 people reported to Consumer Protection losing a total of \$205,250 to tax scams, representing a substantial increase on previous years. In most cases, the victims were asked to purchase iTunes or Google Play cards and supply the codes to the scammers.

Scammers often use the same tactics to dupe victims into this type of scam:

- · Creating a sense of urgency: scammers seek to put their victims under pressure with the threat of arrest unless money is paid immediately.
- Tax scam victims have reported being told their fake outstanding debt needed to be paid immediately or an arrest warrant would be issued.
- They "spoof" phone numbers. Caller ID spoofing allows you to display a phone number different than the actual number from which the call was placed. With caller ID spoofing, you can send and receive outgoing or incoming phone calls or texts that appear to be from any phone number of your choosing. For example, it may appear as if someone is calling from your accountant's office but in reality it's a scammer.
- They may already know some of your personal or financial information, which can make them seem credible.
- They ask for payment via iTunes or Google Play cards and will try to keep you on the phone while you buy the cards. They often tell victims to lie about why they are buying the cards to prevent salespeople alerting them to the fact that it may be a scam.
- · Consumer Protection's campaign targeting the sellers of iTunes and Google Play cards has prevented further losses to gift card scams.
- · Woolworths and Coles have been highly responsive to our campaign to train staff to alert any customers who intend to make large purchases of these cards, which scammers now use as their preferred currency.
- Putting doubt in the mind of scam victims may trigger them to get advice before going ahead with the purchases.
- We urge retailers who sell iTunes and Google Play cards to make sure their staff are aware of this issue and will question customers when they attempt to make purchases involving unusually high amounts of money.
- We want to reduce the community's losses to these types of scams and the cooperation of retailers is vital.

Advice for consumers

- The ATO makes thousands of outbound calls to taxpayers every week, but would never contact you about a debt in a threatening manner.
- The ATO would never demand that you load money onto a prepay card at the post office, ask you to send funds via money transfer services or pay by iTunes vouchers or Google Play cards. ATO methods of payment can be found at www.ato.gov.au/howtopay.
- If the ATO does call to discuss payment of an outstanding debt, they will give you the opportunity to query the outstanding debt with your accountant, other advisers or family.
- Check your myGov account which has real time tax information available, including any outstanding amounts.
- If you have been contacted by the ATO and want to confirm the legitimacy of the contact, take note of the caller's name and details and then call the ATO on 1800 008 540. Most importantly, never send money or give financial details to someone you don't know or trust.
- Be careful when clicking on links, downloading files or opening attachments. Only give your personal information to people you trust, and try not to share it on social media.
- Talk to your family and friends about scams if you or someone you know has fallen victim to a tax related scam, call the ATO as soon as you can or visit ato.gov.au/scams for more information.


