Executive Summary

This submission outlines Centigrade Services' comprehensive proposal to remove and replace the existing air-conditioning systems at the Freebairn Recreation Centre in accordance with RFQ 01-25.

We have proposed the installation of Temperzone ISD 351 LYX / OSA 352 RLTFV R32 inverter systems as the preferred solution, offering high efficiency, strong performance, and full compliance with current refrigerant and electrical standards. The design ensures improved reliability, airflow balance, and reduced energy consumption.

Centigrade's proposal represents not only the most technically compliant solution but also exceptional lifecycle value for the Shire.

Our recommended Temperzone R32 systems deliver substantial energy savings compared to legacy R22 equipment, while providing lower refrigerant costs and simplified long-term maintenance.

The inclusion of locally stocked parts, efficient inverter-driven operation, and full compatibility with future refrigerant standards ensures reduced operating costs and maximum reliability over the system's lifespan.

To support the Shire's decision-making flexibility, we have also provided two alternative system options—ActronAir SCA 290 C / SCG 290 E (R410A) and Mitsubishi Electric PUHY-P250YNW-A1-AU / PEFY-P250VMHS-E (VRF)—each evaluated for performance, efficiency, availability, and cost.

Centigrade Services' local team will manage all aspects of supply, installation, and commissioning within a four-week completion timeframe, ensuring minimal disruption to Centre operations and full post-installation support.

Thank you for the opportunity to quote on your requirements. We have much pleasure in submitting to you our quotation for the following.

Proposal:

Following our recent site inspection, on-site discussions, and as per RFQ 01-25 issued by the Shire of Kulin, we propose to carry out the removal and replacement of the existing Temperzone ISD300 R22 air conditioning systems with new Temperzone ISD 351 LYX / OSA 352 RLTFV R32 systems (approx. 32.7 kW cooling / 31.3 kW heating each).

Scope of Works:

- Isolate and make systems safe, locking out local power supplies.
- Recover and safely dispose of existing R22 refrigerant.
- · Remove existing outdoor and indoor units, associated pipework, and supports.
- Supply and install three (3) new Temperzone ISD 351 LYX / OSA 352 RLTFV R32 systems.
- Install new R32-compatible refrigerant pipework and insulation.
- Reconfigure and shorten existing ductwork to ensure BCA compliance (? 6 m flexible duct runs), including approx. 2.4 3 m of rigid duct per unit.
- Pressure test new pipework to 1.3 x maximum working pressure.
- Evacuate each system to 500 microns and charge with factory-specified refrigerant.
- Commission and test each system to confirm correct operation and performance.
- Remove all redundant materials and debris from site for disposal at an approved facility.

Inclusions:

- All parts, materials, labour, and consumables.
- All travel, accommodation, and meals.
- Testing, commissioning, and provision of O&M documentation.
- Works performed during normal working hours by licensed refrigeration and electrical technicians.
- 12-month workmanship warranty and 5-year manufacturer's equipment warranty

- Any work outside the above scope or discovered during installation.
- Modifications or upgrades to the main electrical distribution board or sub-mains.
